SUBJECT: Legislative Update

Gentlemen,

With the mid-term elections behind us we are now focused on early bill filings and which Senators and House members will assume the leadership positions for the upcoming 86<sup>th</sup> regular legislative session. This session will begin on January 8, 2019 and run for 140 days to May 27,2019. On January 15, 2019 Governor Greg Abbott and Lieutenant Governor Dan Patrick will be sworn in for another four year term. Committee chairs for Senate and House committees will be selected by the new speaker and the Lt. Governor in the early days of the session.

We are reviewing pre-filed bills now and will begin providing you a list of all pension bills filed as session gets started.

### Texas House: Who will be the next Speaker?

The question on who will be the next Speaker of the House appears to be settled. The Texas House Republicans caucus has officially endorsed state Rep. **Dennis Bonnen**, the likely next speaker, for the job. Members of the caucus met in Austin and unanimously voted to back the Angleton Republican. The Republicans Caucus vote, which was the result of a bylaws change members passed last year, comes ahead of the lower chamber's vote in January that will officially determine its next leader. Bonnen has named **Mark Bell** as deputy chief of staff. Bell was a longtime aide to former Democratic Speaker **Pete Laney**. Bonnen also announced Sharon Carter and Hugh Brady as House parliamentarians for the next legislative session. The two were picked by a parliamentarian selection workgroup that Bonnen had assembled and will serve jointly.
