SUBJECT: Legislative Update

Ladies and Gentlemen,

As the Legislature began its work on January 12<sup>th</sup> the House and Senate spent time debating and adopting their rules on how to proceed with business due to COVID 19. After adopting their rules each chamber adjourned until January 26, 2021.

The Senate adopted rules on January 13<sup>th</sup>, and in general will require all Senators and visitors to pass a COVID-19 test before entering the Senate chamber, chamber gallery, or committee hearing rooms. Social distancing and mask wearing will also be enforced. Individual Senators will decide if office visitors will be required to have a negative test wrist band. These rules will be in place for the first 60 days of session and will be reviewed later to determine if changes are needed.

The House adopted rules on January 14<sup>th</sup> which unlike the Senate <u>do not</u> require COVID-19 testing. In general, they do however require all House members and visitors entering the House chamber, the chamber gallery, or committee hearing room to wear a mask and comply with social distancing. Individual members will decide if office visitors will be required to have a negative wrist band.

COVID-19 testing and wrist bands are provided in a tent at the Capitol's north entrance. As you can imagine the COVID-19 rules will definitely make it more challenging to operate around the Capitol. All hearings and floor debates will be available online.

The Texas House and the Texas Senate re-convened Tuesday January 26<sup>th</sup>. After conducting its business, the Texas Senate adjourned until Tuesday February 9th at 3 PM. The House adjourned on January 27<sup>th</sup>. until Tuesday February 9<sup>th</sup> at 2 PM.

# **Pension Review Board of Texas:**

The Review Board has no posted meetings for 2021.

Governor Greg Abbott has appointed Robert Ries to the State Pension Review Board for a term set to expire on January 31, 2023. The board reviews all Texas public retirement systems, both state and local, for actuarial soundness and compliance with state law.

Robert Ries of Austin is the Deputy Executive Commissioner for Compliance and Quality Control for the Texas Health and Human Services Commission (HHSC), and previously served as a Senior Advisor to the Chief Policy and Regulatory Officer for HHSC. Prior to his work as HHSC, he served as the Budget and Finance Director for the Texas Facilities Commission. Ries earned a Bachelor of Arts in Economics from The University of Texas at Austin and a Master of Business Administration from Texas State University.
